# MINUTES OF PLANNING AND SERVICES COMMITTEE MEETING HELD ON THURSDAY 4TH MAY 2017 AT PULBOROUGH SPORTS AND SOCIAL CLUB

The meeting opened at 7.30pm

#### 212. APPOINTMENT OF CHAIRMAN

It was noted that as both the Committee Chairman and Vice Chairmen were absent, it would be necessary to appoint a chairman for the meeting. Following nomination and voting, it was **RESOLVED** to appoint Cllr C Esdaile as Chairman for the meeting.

# 212. APOLOGIES FOR ABSENCE

Apologies for absence were received and accepted from Cllrs Tilbrook, Wallace, Quested & Wilson.

# **213. DECLARATIONS OF INTEREST & CHANGES TO REGISTER OF INTERESTS**There were no changes to Register of Interests.

Cllr Lawson declared a personal but non pecuniary interest in agenda item 5, planning applications - DC/17/0946, Garden View, The Street, Nutbourne as this is a neighbouring property and Cllr. Kipp declared a personal but non pecuniary interest in agenda item 5, planning applications - DC/17/0928, Brookview, Rectory Lane as this is also a neighbouring property.

# 214. MINUTES

The Committee **RESOLVED** to agree and approve the Minutes of the Meetings held on 6th & 20th April 2017 and that the Chairman duly signed them.

# Item 160 - Traffic Calming - Broomers Hill Lane

# 217. PLANNING APPLICATIONS DECISIONS

Members received details of HDC planning decisions and enforcements since the last meeting.

#### 218. FUNDING FOR PAVEMENTS

Cllr. Kipp explained that Cllr. Pat Arculus had advised that funding was available for pavements that needed repairing, as many pavements in Pulborough do. The funding application process has now closed, but Cllr. Arculus will find out if a new round of funding will be available in the near future. The Deputy Clerk will diary this matter accordingly and report back when applicable.

#### 219. PARKING RESTRICTIONS ON CORN STORE CAR PARK

Cllr. Kipp explained that the car park over the bridge near the Corn Store is owned by Highways, but is not an official car park; however commuters use it all day, which prevents shoppers using it for short periods of time. At the Full Council meeting on 20.04.17, Cllr. Pat Arculus advised that a TRO (traffic regulation order) can be applied for through the County Council's website to apply parking restrictions, whereby parking can only be for a certain period of time. Members noted that the car park was in Coldwaltham's Parish, but Cllr. Arculus has advised that Coldwaltham Parish Council are happy for a TRO to be applied for. The Deputy Clerk advised that Cllr. Arculus said she would put in a TRO. Members instructed the Deputy Clerk to ascertain what restrictions Cllr. Arculus intends to apply for and bring back to the Annual Meeting of the Council on 18th May 2017.

# 220. TRAFFIC - NEW PLACE RD

Cllr. J Esdaile advised that cars have been parking in New Place Rd all day, restricting traffic flow and it is believed to be employees from local businesses as there are not so may cars over the weekend. However, recently, the Neighbourhood Wardens (NHWs) have spoken to the local businesses and the situation doesn't seem so bad. The situation will be monitored and Members noted the NHW's help and appreciate their efforts in this matter.

# 224. REVIEW IMPACT OF CAR PARK CHARGING SCHEME ON STREET CAR PARKING AND EMERGENCY ACCESS

Cllr. Henly advised that the new parking charges were having an impact with cars parking in Allfrey Wharf, however the NHW's have yet again spoken with people and this situation has appeared to have stopped. Members spoke at length about the parking issues now that the parking charges have been introduced and this was brought up at the recent HALC meeting. HALC will be asking HDC to provide a review in November and Cllr. Kipp will feedback to Council accordingly.

There are also parking problems with trader and staff parking in the lay-by near the dry cleaners, parking there all day (despite the parking restrictions), preventing shoppers using these parking places for quick stops in Lower St. Members noted these parking issues are an ongoing problem. Members instructed the Deputy Clerk to add this matter to the Full Council agenda in October 2017, so that the position can be reviewed before the HALC meeting in November.
