- We had a meeting with a resident to discuss concerns they have for a neighbour. Issues are related to ASB and safeguarding of young children exposed to drug use.
- Resident signposted to Police and housing provider regarding complaint of cannabis use at property.
- Report received of motorbikes riding on the recreation ground and inside the playground area.

Parking/vehicles

Operation crackdown reports:

- 1. Abandoned minibus was moved on.

- Worked with residents in Arun Prospect to alleviate parking problems linked predominately to train commuters.
- Currently working with the industrial estate businesses and Fluid Adventures (water sports company) for their customers to have weekend parking as a solution to the overcrowding in the surrounding residential roads.

Community engagement/events/meetings

- Attended a PCP (Pulborough Community Partnership) meeting to support young people promoting the pump track project.
- Met with member of the PCP to discuss development of the annual duck race to a wider water festival to be held on 6th June 2020.

Patrols (foot/visible and car)

- Mobile patrols to cover Nutbourne, Blackgate Lane, Pickhurst Lane, Broomers Hill, London Road, Gay Street Lane and Stane Street.
- Foot patrols to Primary School, recreation ground, Cousins Way field, Glebe fields, Station Road, Train Station, Church Road and London Road.
- Targeted patrols to monitor fly tipping and train departures/arrivals of local students.
- Park Mound area/woodland to monitor bike riding and youths gathering.

Elderly and youth

- Resident signposted and advice given on mental health support services.
- Engaged with vulnerable resident with Alzheimer's and partner for local services and further support.
- Assisted resident with noisy disturbance from a delivery company.
- Signposted and advice given to resident with concerns for welfare of a friend.
- Query raised with Hop Oast (Household waste recycling site) regarding vulnerable couple and persistent overflowing bins issue.
- Joint working with Community link team to assist vulnerable resident who has handed back alarm.

- Signposted and arranged for a mobile hairdresser to visit vulnerable older resident.
- A reassurance home visit to an older vulnerable resident following a planning issue.

Youth:

- Engaged with families and young people to join a working party for bike pump track project.
- Visited home of pupil on school exclusion.
- Shared best practice with Southwater Wardens with setting up a walking school bus to help alleviate parking following its success here in Pulborough.
- Worked with Sussex Clubs for Young People (SCYP) to join us for our half term sports events and future outreach work in the community. SCYP are arranging for the mobile purple bus youth provision to come to Pulborough.
- Referred young person to Anti-social behaviour team for early intervention support.

Licensing

Dog related issues

- Engaged with and advised residents who are allowing their dogs to run loose in the road and not securing garden boundaries to prevent it.
- Dog fouling problem has been reported in Stane Street and Spinney North.
- New signs have been placed and dog walkers in the areas have been spoken to.
- A resident has been given a hi-vis spray to bring attention to the owners responsible and to help people avoid stepping in the mess.

Cycling

Reports received of young people riding bikes and constructing ramps in a woodland area which is on heritage protected land. We have visited the site and will continue to monitor and make enquiries with relevant the organisations.

- Signposted local fitness group to our Health and Wellbeing team at HDC to give 'body MOTs'.
