### Local Plan Review – Joint Parish Councils Meeting

A joint Parish meeting with West Chiltington Parish Council (WCPC), Billingshurst Parish Council (BPC) & Pulborough Parish Council (PPC) was held on 3<sup>rd</sup> March, initially, to discuss a consolidated approach to the proposed development at Adversane. A further meeting is to be held on 24.03.20.

From this meeting BPC extended an invitation to WCPC & PPC for one representative to attend their next Local Plan Working Party meeting, being held on Monday 9<sup>th</sup> March. The Deputy Clerk has emailed all attendees to see who is available to go, but not received any replies from ClIrs who may be able to attend. Please can Members advise if they wish to send a representative. *Unfortunately there was no-one available to attend the meeting as most Members were at another PPC meeting.*

### 139. PARSONS FIELD STABLES APPEAL – REF APP/Z3825/W/20/3246486

Cllr. Wallace advised that the work was ongoing for this appeal, there is no hearing date yet, so Cllr. Wallace will report on this matter at the next meeting.

### 140. HORSHAM DISTRICT COUNCIL'S LOCAL PLAN 2019 – 36 REGULATION 18 CONSULTATION

Members received details of the above consultation and discussed some of the general issues that will affect Pulborough and surrounding areas. As stated in the Clerk's report a joint Parish meeting was held in order to look at potentially submitting a joint Parish submission to the consultation, but Members commented that a submission should also be sent from PPC. Members suggested that each P&S Committee member should send their comments, in bullet point form, on the Local Plan to the Deputy Clerk by Tuesday 10<sup>th</sup> March 2020 in order for them to be collated ahead of the Full Council meeting on 19<sup>th</sup> March, when this matter will be discussed further and final comments will be made in order to submit them to HDC.

## 141. SOUTH DOWNS NATIONAL PARK AUTHORITY'S (SDNPA) SUSTAINABLE CONSTRUCTION SUPPLEMENTARY PLANNING DOCUMENT (SPD) CONSULTATION

Members received the above consultation, Members regretted that they were unable to comment due to the submission of letter dated 11th Feb and tight deadline imposed.

### 142. SALT BIN ON BROOMERS HILL LANE

The Deputy Clerk advised that when speaking about the agreed replacement salt bin to the resident, who's property boundary the salt bin was placed in, the resident advised that they would prefer not to have it replaced as it was installed before they moved in and did not want it situated within their property boundary. Having looked at the street view maps, the Deputy Clerk advised that there isn't anywhere suitable nearby to place it. Therefore, do Members want to consider not replacing it? Members **RESOLVED** to not replace the salt bin.
