E-CINS: Online confidential multi-agency sharing of caseloads.

Operation Crackdown: Joint initiative with Sussex Safer Roads Partnership and Sussex Police to report abandoned vehicles or anti-social driving.

SCYP: Sussex Clubs for Young People.

ASB: Anti-social behaviour.

HASBRAC: Horsham Hate Crime and ASB Risk Assessment Conference.

DPA: Directed Patrol Activity (Sussex Police)

Section 59: Allows the police to give drivers a warning if they are reported to have used their vehicle in a manner which causes “alarm, distress or annoyance”. If reported to have done so again within a year the police have the right to confiscate the vehicle.

ASB/crime/criminal damage

- Advice given to 4 x households who are experiencing ongoing neighbour nuisance issues. Shared information with relevant agencies.
- Provided information relating to criminal damage to the playground equipment on the recreation ground.
- Submitted intelligence regarding suspected drug supply.

- Supported resident who reported a firearms incident to the Police.
- Further signposting given to New Place Nurseries following more damage to their electric pump house.

Parking/vehicles

- 6 x Operation Crackdown reports submitted
- Words of advice given to rider of an electric scooter. Several complaints received relating to this issue.
- 3 x DVLA reports for untaxed vehicles kept on the road.
- 2 x parking alerts for poor parking.
- Reports of anti-social use of motorcycle. Police aware.

Fly tipping/littering/graffiti

- 3 x hazards reported:
 1. Overhanging tree in Lower Street.
 2. Pothole and broken road surface on the A29 Church Hill.
 3. Pothole in Rectory Lane.

Community engagement/events/meetings

- Joint working with Pulborough Sports Social Club and Football Club regarding use of the full size goals for young people to enjoy games on the recreation ground.
- Support given to Pulborough Society with Heritage Open Day through grants and signposting.
- Recruited more people for our Mens Shed project.
- Recruited 2 x volunteers for local clubs (minibus escort/befriending)
- Attended 'Child in Need' meeting to support local family.
- Attended Joint multi agency operation to provide a reassuring presence and engagement with young people in Horsham Parks following recent suicides in the District.
- Planned and advertised 'Talking Tent' project – Sessions held on the recreation ground throughout August for young people and families to access information relating to mental health concerns.
- Attended Farmers Market for 'meet and greet' with residents.

Patrols (foot/visible and car)

- Mobile patrols of the whole parish during every shift targeting hot spot areas.
- Increased foot patrols to check open spaces i.e. recreation grounds/playground equipment and to engage with groups gathering.
- Visits to homes/businesses keeping within social distancing guidelines.
- Joint patrols with PCSO's and other warden schemes when required to tackle ASB.

Elderly and youth

- Link alarm home visits to test alarms and to offer further support and signposting if needed. Support given to resident with poor sight.
- Worked in conjunction with the Police to support a vulnerable resident.
- Liaised with Weald Head of House regarding safeguarding concern of a student.

- Arranged safe and well visit for young person by West Sussex Fire Rescue.
- Referred vulnerable resident to get help with managing finances.
- Welfare visit to a vulnerable resident following concerns raised by a neighbour for their decline of mental health following lockdown restrictions.
- Weekly attendance to Purple Bus youth sessions for engagement with young people and families.

- Reassurance and advice given to resident who was a victim of a failure to stop from a road traffic collision, no injuries sustained.
