DC/16/1564 - Land West of Nutbourne Lane Nutbourne Pulborough

Creation of new access to serve an existing vineyard.

DC/16/1654 - Oddfellows Arms 99 - 101 Lower Street Pulborough

Repair or replacement of a cracked timber beam to the first floor front elevation of an existing public house building (Listed Building).

DC/16/1611 - 8 Swan Corner Pulborough

Remove existing south facing balcony steel railings and replace with stainless steel posts and glazed infill panels. Replace existing white upvc doors to existing south facing balcony and replace with new white upvc sliding door and fixed panel. Replace 1st floor south facing white upvc window with new white upvc window in identical proportions.
