ASB crime/criminal damage

- Several calls were received about anti-social use of motorcycles. Police and fire attended an incident in Coombelands Lane.
- Following reports into ourselves and the Police, we engaged with the Police rural crime team regarding continued criminal damage at New Place Nurseries and our concerns that it was repeatedly being targeted.
- HDC's anti-social behaviour team sent letters to homes of young people breaching Covid guidance during lockdown.
- Incident diaries and advice given to resident in neighbour dispute. Information was shared with relevant agencies.
- Calls received about young people gathering at Brookfields new build. We patrol the area, engage with young people and shared our warden information leaflets/contacts with new residents.
- Completed an environmental and visual audit in Church Place after incidents of anti-social behaviour.
- Report to Police following incident during school parking enforcement.

Parking/vehicles

- 14 x reports to Operation Crackdown – Parking on yellow school zig zags, Rivermead (parking on pavements) and Lower street.

Fly tipping/littering/graffiti

- 2 x reports submitted for collection of Fly tipping in Stopham Road.
- Collection arranged for abandoned shopping trolleys in Link Lane.
- Reported fly tipping in Rivermead with line of enquiry to the Operations team.

Community engagement/events/meetings

- We continue to engage with residents/young people when on our foot patrols. Unfortunately, local clubs are still closed due to Covid and our meetings have been held virtually.

Patrols (foot/visible and car)

- We do mobile patrols of the entire parish during every shift and target hot spot areas associated with ASB.
- Increased foot patrols to check open spaces i.e. recreation grounds/playground equipment and to engage with groups gathering.
- Visits to homes/businesses keeping within social distancing guidelines.
- Patrols increased to woodland areas in response to reports of campfires.
- Patrols at bus stops/train station to meet pupils travelling to and from the Weald School and colleges.

Elderly and youth

- Arranged for a volunteer to assist an elderly resident for a weekly 'walk and talk'.
- Engage with SCYP relating to youth provisions, focussing on outreach work in the community and to discuss young people of concern.
- Multi-agency meeting to collate information around young people of concern and are coming to our attention. A mapping exercise helped us to look at friendship groups/associations that links groups/meeting places etc.
- Reported male to Police and Adult Social Care services following community tension and concerns raised around suspicious behaviour.
- Joint visit with ASB caseworker to Weald School for early intervention support with pupil.
- 2 x young people referred to Early intervention Project (Multi-agencies provide early intervention support to young people with concerning behaviour/staying safe out in the community).
- Welfare calls to vulnerable residents to offer support.
- Assisted vulnerable resident with obtaining furniture in their property.
- 3 x safeguarding referrals. (1 x adult 2 x child).

Licensing

- Nothing to report.

Dog related issues

- Report to housing provider following complaints that tenants were allowing their dog to foul in a communal area.

Cycling

- Nothing to report.

Parish specific/other

- Assisted resident with query over potential business Covid breach.
- Engaged with Tesco Manager regarding rise abandoned shopping trolley's in the community.
- Assisted Police with search for missing young person. Found safe and well within 10 minutes.
- Joint working with Storrington Wardens to patrol and identify young people travelling between the two villages.
- Joint patrols at The Weald School to engage with young people gathering/smoking cannabis at the green shelter.
- A volunteer was signed up to Adopt-A-Street project in North Heath.
- Vanessa completed training to become a Mental Health First Aider for young people.
