# 27. MINUTES

The Committee **RESOLVED** to agree and approve the Minutes of the Meeting held on 11<sup>th</sup> July 2024 as a true and accurate record of the proceedings and the Chair signed them.

# 28. PUBLIC SPEAKING

There were no public speakers present and therefore the Chair moved on to the next agenda item.

# 29. RECREATION CLUB REPORTS

A Cricket Club representative came and gave an update to members on the Cricket Club .

A new treasurer was in post treasurer for the cricket club in June of this year. The season is now finished, the team played fourteen games; winning three which was a bit of a disappointment. Several players were injured during the season, and although the team is staying in Division Twelve, they finished second in the league

making it a reasonable season overall. The players are content with their performance.

#### 32. OAK TREE WITH HONEY FUNGUS ON RECREATION GROUND

Members considered felling the oak Tree at the end of Collingwood it has Honey Fungus which could spread to other trees.

Members **RESOLVED** to accept that the tree needs to be felled, the Deputy Clerk will look into applying for planning permission due to the oak tree having a TPO on it. Members wanted it noted that the waste is not to go to landfill but to biomass recycling.

# 33. RECREATION GROUND SIGNAGE

Members considered erecting further signage for owners to keep their dogs on a lead. Cllr Clarke stated that we would be unable to enforce this, there was a lot of discussion around this, we do encourage good behaviour and the signage may encourage good behaviour. Cllr hunt suggested the signage should say dogs must be kept under control.

Members **RESOLVED** to the wording to the above and agreed to be put on the entrances for Pocket Park and opposite school.
