E-CINS: Online confidential multi-agency sharing of caseloads.

Operation Crackdown: Joint initiative with Sussex Safer Roads Partnership and Sussex Police to report abandoned vehicles or anti-social driving.

SCYP: Sussex Clubs for Young People.

ASB: Anti-social behaviour.

OP APOLLO: Sussex Police COVID-19 response.

DPA: Directed Patrol Activity (Sussex Police)

Section 59: Allows the police to give drivers a warning if they are reported to have used their vehicle in a manner which causes “alarm, distress or annoyance”. If reported to have done so again within a year the police have the right to confiscate the vehicle.

ASB crime/criminal damage

- Signposted 2 x residents to police re behaviour of suspicious male.
- 999 call made to assist vulnerable adult.
- 3 x Police intelligence:
 1. Suspicious activities of a person.
 2. Info relating to a weapon.
 3. Suspected drug dealing x 3. (Signposted residents to report incidents into the police).
- Advised resident to report cold callers knocking at properties in Nutbourne.
- Support given to resident re concern for insecure shop premises.
- Advice given to resident with matters relating to an ongoing neighbour dispute. Signposted resident to report incidents to the police.
- Engaged with group of young people climbing on the youth shelter roof.
- Supported cricket club with concerns about young people climbing on to the sports pavilion roof and playing football on it.
- Reports received of young people vandalising fencing panels in Pocket Park. Young people were verbally abusive when behaviour challenged by witnesses.
- Collated information regarding a noise complaint (music) and sent to Environmental health team.

Parking/vehicles

- 1 x parking alert issued for vehicle preventing pavement access.
- 2 x joint patrols with parking services to monitor outside the school.
- 1 x parking ticket issued (HDC) for parking on school zigzags.

Fly tipping/littering/graffiti

- Fly tipping reports submitted x 2
 1. Fly tipping report in Stream Lane.
- 3 x abandoned shopping trolleys reported to Trolleywise. Spoke to Tesco re collection point locally and frequency of incidents.
- 4 x potholes reported:
 1. A29 London Road.
 2. Gay Street Lane.
 3. 2 x Broomers Hill Lane.
- Engaged with new residents to the area about litter picking groups locally.

Community engagement/events/meetings

- Meetings attended continue to be held virtually:
 1. Wilder Horsham Meeting.

2. Meeting with stakeholders regarding Mens Shed and community garden project locally.
 3. Attended multi agency meeting to address the rise in isolation and loneliness across the District.
- Engagement with teachers/parents during foot patrols at school drop off and collection times.
 - Engaged with water user groups regarding planned closures at Swan and Stopham Bridge.
 - Supported PDCCA Wednesday Lunch Club with finding new volunteers to help provide the service.

Patrols (foot/visible and car)

- Mobile patrols of the whole parish during every shift targeting ASB hot spot areas and Covid-19 breaches.
- Foot patrols to check open spaces i.e. recreation grounds/playground equipment
- Patrols increased to woodland areas in response to reports of bike ramps and campfires.

Elderly and youth

- We are making welfare calls to our vulnerable older residents identified from requesting support during the first lockdown and Community link alarm customers that live in our Parish, signposting to support agencies when required.
- Signposted resident to the police and adult social regarding concerns for vulnerable male.
- Advice given and resident signposted for home security system following incidents at the property.
- Joint visit with ASB caseworker at local secondary school to support young person. Around staying safe when out in the community.
- Engaged with SCYP and provided funding support for new equipment from the Police Property Act Fund.
- Linked SCYP up with Wilder Pulborough Project as part of the Wilder Horsham District initiative with Sussex Wildlife Trust to encourage young people to become involved.
- 2 x safeguarding referrals.
- 1 x phone call with WSCC Adult Services.
- 1 x phone call with support worker (Prospect Neurological support).

Licensing

Dog related issues

- Spoke to dog owner regarding complaints that their dog was barking at unsociable hours.
- Report received that dogs are not kept on leads around cattle.
