Recommendations of the Planning & Services Committee meeting held on Thursday, 4th October 2018

PLANNING APPLICATIONS

DC/18/1918 - Roseacre Stall House Lane North Heath Pulborough

Erection of a two storey detached dwelling and associated access onto Stallhouse Lane. No objection, but Members would request that HDC consider the points raised within the representation letter from a neighbouring property.

DC/18/1996 - Beeding Granary Gay Street Lane North Heath Pulborough

Variation of condition 1 on previously permitted application DC/18/0477 (Conversion of domestic garage to a residential annexe for occupation ancillary to main dwelling. Associated external alterations including erection of front porch and installation of roof lights. (Listed Building Consent)) Relating to re-positioning of a roof light and retention of garage doors on southern elevation. Retention of existing opening, insertion of replacement windows and re-location of door on northern elevation. **No objection.**

DC/18/1868 - North Wing Holme Manor Mare Hill Road Pulborough

Erection of a single storey side/rear extension with roof light. **Objection**, the proposed style of the single storey is not in keeping with the existing property. If the style was changed to be more cohesive, then Members would change their objection.
