# ASB/crime/criminal damage

- We received a call reporting ASB of door and window knocking. The group involved have been identified and advice given.
- Engagement with landowners of Harwoods and New Place Nurseries relating to young people gathering and building bike ramps.
- Young people were riding a motorised quad bike on the main recreation ground. The quad bike was removed after we spoke to the parents of those involved.
- Advice was given to trader who reported ASB outside their shop.

- Advice given to a milkman following theft of items from his vehicle. We then completed follow up visits to speak to parents at the homes of young people involved.
- We spoke to Tesco management relating to young people gathering outside of their store.
- Support and advice given to resident regarding an ongoing property dispute.
- We liaised with the landowners of The Moat regarding damage to the Historic England site caused by digging and building of bike ramp structures. A number of young people were also spoken to.
- We submitted 2 intelligence reports to the police regarding drug supply within the Parish.

# Parking/vehicles

- 2 x vehicles parked in New Place Road reported for no Tax or MOT.
- 3 x vehicles reported to Operation Crackdown.
- Intelligence received re suspicious vehicle believed to be drugs related.
- 2 x parking alerts on vehicles causing an obstruction.

# Fly tipping/littering/graffiti

- Reported further illegal fly posting. Horsham District Council taking the lead with a CPW. (Community Protection Warning letter)
- Reported fallen tree, obstructing highway in Broomers Hill.
- Offensive Graffiti removed from vehicles parked in New Place Road.

# Community engagement/events/meetings

- We have completed site visits regarding the Mens Shed and Community Garden projects.
- We attended a meeting with the Fire Service at Billingshurst fire station to discuss joint working to identify vulnerable people and hot spot areas.
- We attended a joint session with a youth worker to explore Bike Pump Track options within the Parish.
- We attended Village Market for 'meet & greet' session.

# Patrols (foot/visible and car)

- Mobile patrols of the whole parish during every shift targeting hot spot areas.
- Increased foot patrols to check open spaces i.e. recreation grounds/playground equipment and to engage with groups gathering.
- Visits to homes/businesses keeping within social distancing guidelines.
- Joint patrols with PCSO.

### Elderly and youth

- Further support given to vulnerable resident to assist with food shopping deliveries.
- Further engagement with services supporting older vulnerable resident following crisis intervention.
- Supported and signposted parent worried about their teenager's behaviour due to substance and alcohol.
- We completed a safeguarding referral for young person.
- We attended a joint session with Sussex Clubs for Young People.
