# Recommendations of the Planning & Services Committee meeting held on 1st August 2024

#### PLANNING APPLICATIONS

The Committee will consider the following planning applications:

## DC/24/1022 - Mount View, Stane Street, North Heath, West Sussex

Variation of Condition 14 of previously approved application DC/23/1108 (Non Material Amendment to previously approved application PL/107/03 (Erection of 1 bungalow, Site: Mount View Stane Street North Heath) to add a 'Plans' condition to the approval letter to include the most recent approved drawings) to vary design and scale of the building.

**PPC Comments objection:** concerns were raised regarding overdevelopment of the site with buildings being very close together which could pose a fire risk, the south side has no windows with the north side having four windows planned which overlook a neighbouring garden consideration needs to be given loss of privacy.

## DC/24/0623 - Coombelands Equestrian, Stane Street, Codmore Hill, West Sussex

Replace warm up area with the erection of a show jumping arena, viewing gallery and provision of grass summer parking area.

**PPC Comments objection:** The transport statement does not seem to have been amended, concerns were also raised about the local flood document which states that the material for the development will be porous and not permeable, and the fire document raising fear that the fire hydrant is not an acceptable distance required for a commercial premises.
