- initially for four weeks






HDC have supplied signage to help keep on street parking available

- However, the Pulborough Footfall trend does not reflect the business impacts seen



- Dec 28th Emergency call out to blocked road
- Road closed
- Temp Diversion in place

Response - Immediate



- Site Inspection
- Advice Note
- Diversion Route set up
- More robust road closure
- Weekly stakeholder update

Response – Longer Term



- Regular Inspection of diversion route
- Web site
- Liaison with land owners + draft agreement
- Legal advice
- Technical advice

- Awaiting formal investigation
- Weather

Phase 1



- To enable full and detailed site and ground investigation to establish the extent of the problem and appropriate options to resolve on the short and intermediate term
- The removal and/or cutting back of vegetation, undergrowth and trees
- The scraping (and removal from site) of failed soil material
- Benching (the formation of horizontal levels or steps to provide lateral support to steep embankments) of the embankment
- On a temporary basis until such time as a permanent engineering solution has been identified and agreed:
- If feasible to provide additional temporary support at the toe of the embankment on the Licence Land as required
- Pin, sheet and cover the affected embankments to protect from future weather events



Phase 2



• further detailed site and ground investigations to inform and establish potential options and solutions in the longer term.

Phase 3



- Permanent measures required to enable the County Council to discharge its duties under the provisions the Highway Act 1980
- The construction and permanent installation and retention of materials and objects as appropriate to enable the structural stability of the Licence Land and continued safety of the highway
