Recommendations of the Planning & Services Committee meeting held on Thursday 17th January 2019

DC/19/0007 – Plovers Tudor Close Pulborough

Erection of a single storey rear extension and patio, driveway alterations and installation of a garden wall. No objection.

Cllr Quested declared a personal interest in the following planning application as the applicant was known to him.

DC/19/0002 – Wild Brook House Rectory Lane Pulborough

Installation of 3 No. new dormer roof windows to front elevation. No objection.

DC/18/2340 - Middle Barn Farm Coombelands Lane Pulborough

Equestrian development for personal use comprising of a partially submerged barn for stables, feed store and machinery; outdoor school and horse exerciser. Creation of an earth bund; associated hardstanding and retrospective consent for resurfacing an existing access. (Amended plans)

Objection: The Council did not object to the original application, however, it is now aware of further information such as residents' objections and has concerns over possible site access from the north. Whilst the amended application is an improvement to the original, the Council would prefer to see the development moved to the south, taking into account the site of the water main.

DC/18/2754 – Land Rear of 1 to 6 Aston Rise Pulborough Fell 1 x Alder and surgery to 1 x Willow and 1 x hedge. No objection.

DC/18/2752 – Oddstones Codmore Hill Pulborough Surgery to 1 x Oak. No objection.

DC/18/2664 – Glebelands Pulborough

Surgery to 1 x Beech and 1 x Sycamore. No comment.

DC/19/0043 – Milton Church Place Pulborough Fell 1 x Almont tree (Works to trees in a conservation area). No objection.
