**F&P 001 Apologies for Absence**

**F&P 005 Grass Cutting**

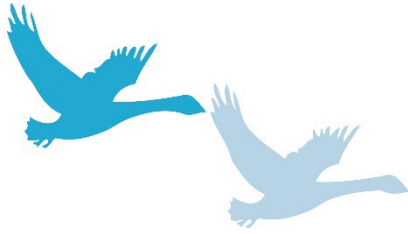

**F&P 006 Change of office**

The need for a new carpet in the office area was discussed, and it was agreed that the council would take responsibility to replace the carpet in these areas.

**F&P 007 Memorial Garden and Community Allotment budget to be combined**

The Clerk outlined the proposal from the Recreation and Open Spaces Committee to merge the Memorial Garden and Community Allotment budgets, with any income allocated to an Earmarked Reserve (EMR) to be used solely for the Memorial Garden and Community Allotment.

It was **resolved** to proceed with the request from R&OS and combine the two areas into the same budget.
